3. Estimates: Review of 2013 / 2014

4. Precept: Consideration of setting the precept for 2014 / 2015.

4.1 Letter re Tax Base / Precept from DCC

A letter from Paul Darby (Financial Officer, DCC) dated 25th November had been circulated with the agenda. This gave details of the revenue support grant and the subsequent reduction in the Localising Council Tax Support Scheme (LCTSS) available and in particular the figures as will apply to Sedgefield Town Council. This also indicated the amount of the precept which would result in a zero increase in the council tax for Sedgefield.

A further letter from Mr. Darby dated 21st December was circulated at the meeting. This

followed the meeting at County Hall of the Local Councils Working Group earlier that day which the Clerk had attended. This confirmed that there had been a marginally smaller decrease in the revenue support grant which would have a very minor impact on the LCTSS grant and subsequently on the amount of precept which would lead to a zero increase on the council tax as above. DCC have indicated that this adjustment will be made to the 2015 / 2016 grant allocation thereby ensuring that the figures which the town council have already used to calculate the precept for 2014 / 2015 may remain.

RESOLVED

To receive the information and to use the figures as calculated to determine the precept for 2014 / 2015.

4.2 Financial Budget Comparison 2014 / 2015

The draft estimates for 2015 / 2016 had been circulated.

The Chairman, Cllr. Gloria Wills and the Clerk answered all queries / questions on these.
